# Our sustainability and DEI

## **Recycling, re-use and waste minimisation**

### **Paperless office**

We were the first paperless law firm in Ireland. Our decision to go paperless means that we have significantly reduced our CO2 emissions and carbon footprint.

### **Composting**

We compost by segregating food waste from the general and recycling wastes. This initiative is aimed at reducing the amount of food waste accumulated in the office, which ultimately ends up in landfills and produces methane emissions.

## **Battery bins**

We introduced battery bins throughout the office to collect any depleted batteries. These batteries are then delivered to a local authority recycling centre to ensure they are disposed in a safe manner.

## **Other initiatives**

We have established agreements of responsible disposing with many of our suppliers to ensure that our goods were being correctly managed after we were finished with them. This included company seals, printer toners and glass bottles to name but a few. The suppliers collect our waste monthly as set out in the agreement, allowing us to maintain our high standard of waste management and minimisation.

## **Bio-diversity and improving natural habits**

### **Green spaces**

We're working with our landlord to create a more bio-diverse environment between the office and the canal where we're located, to be a more friendly space for local wildlife and pollinators.

We are also working on installing two bee hives in this new green space.
